Payment Examples: (Payment examples do not include amounts for taxes and insurance premiums. The actual payment obligation will be greater.)

Non-Rebate Eligible Fixed Rate Mortgage

Borrow \$200,000 at 7.000% with 360 monthly (30-year term) principal and interest payments of approximately \$1330.60.

Rebate Eligible Fixed Rate Mortgage

Borrow \$200,000 at 8.750% with 360 monthly (30-year term) principal and interest payments of approximately \$1573.40.

Single Advance Home Equity

Borrow \$60,000 at 9.250% with 180 monthly (15-year term) principal and interest payments of approximately \$617.52.
